

Call for applications Become an accredited Climate Fresk facilitator

Running parallel to the <u>13^e Economic Forum of the Indian Ocean Islands</u>, Cap Business Océan Indien will be organising a training course for independent consultants specialised in sustainable development and the environment who already provide inhouse training and coaching services to companies. This initiative aims to train accredited facilitators in order to provide Climate Fresk workshops in territories across our region. This 5-hour training course will take place in Mauritius on Friday 14th October 2022, and will be led by an accredited <u>Climate Fresk</u> trainer. Costs related to this training will be fully covered by Cap Business Océan Indien, thanks to support from Agence française de développement (AFD).

Who can take part?

This call for applications is open to independent consultants whose fields of expertise are sustainable development and the environment, and who already provide in-house training and coaching services to companies in the region. Individuals must be based in one of the region's six territories, namely Comoros, Madagascar, Mauritius, Mayotte, Reunion or Seychelles.

Candidates must first register for the 13th Economic Forum of the Indian Ocean Islands and participate in one of the Climate Fresk workshops that will be organised during the event to be held at the <u>Caudan Arts Centre</u> in Mauritius from 11th to 13th October 2022. It should be noted that related costs such as registration, travel and accommodation (for non-Mauritian residents) will be borne by each participant.

Are there any specific commitments?

Yes - it is compulsory for course participants to sign a <u>cooperation charter</u>. A signed copy of this document must be attached to the application email. Any applications without this document will not be considered.

How to register?

For those who wish to apply, the process is very simple: just send your CV and the signed cooperation charter to <u>mickael.apaya@capbusiness.io</u> before <u>16th September</u> <u>2022</u>. Confirmations will be sent to selected candidates by 21st September 2022, at the latest.

Will there be a selection process?

Only 5 places are available. In the event that applications exceed this number, a selection will be made based on the candidates' professional experience and academic background.

Gender criteria will be applied, in line with Cap Business Océan Indien's commitment to promoting the inclusion of women and young people in economic activities across the region.

What is The Climate Fresk?

Founded in 2015, The Climate Fresk is a card game seeking to simplify the mechanisms of climate change, as explained in IPCC reports. It has been distributed worldwide since 2018 by a non-profit organisation bearing the same name. Each session lasts 3 hours and is divided into 3 phases: technical, artistic and debriefing.

Objectives:

- to develop a common knowledge within companies on climate issues
- to bring people together through creative collaboration
- to raising awareness and understanding about climate change
- to help employees to commit to ecological transition
- to provide the necessary keys to act both individually and collectively on a daily basis
